## JUSTIFICATION FOR RECUSAL AND DISQUALIFICATION

- A. Obstruction of Justice: Accessory to Crime/Obstructing a Peace 12 Officer/Compounding/Abuse of Public Records/Duty to Report a 13 Crime and Other Crimes Not Listed Here (Statutory, Civil, and 14 Constitutional) Committed by Julie Kunce Field 15
- a. Julie Kunce Field has ordered multiple law enforcement officers in 16 multiple jurisdictions in two counties to stand down.

52	g.	Ryan Berg, acting as a law enforcement officer for the Larimer County	
53		Sheriff's Office, assaulted a senior citizen in the court room.	
54	h.	Ryan Berg ordered all occupants of the court room to leave the Larimer	
55		County Justice Center.	
56	i.	Ms. Lynne left the Larimer County Justice Center as ordered by Ryan Berg	
57		and proceeded to deliver the void judgment to the Weld County Sheriff's	
58		Office, the Larimer County Sheriff's Office, the Larimer County	
59		Commissioner's Office, the Larimer County Justice Center, and other	
60		public locations.	
61	j.	Ms. Lynne was never contacted to return to the hearing that was vacated	
62		by Julie Kunce Field when she fled from the building (See Ryan Berg's	
63		"Incident Report": EXHIBIT).	
64	k.	Julie Kunce Field, Amy Antomarria, and Traci Christy (illegally acting as	
65		an attorney) held a secret hearing that Stacy Lynne had no knowledge of	
66		until an order was mailed to her that was issued as a result of that secret	
67		hearing.	
68	l.	Julie Kunce Field and Ryan Berg and Amy Antomarria then reported, all	
69		in writing, three different accounts of what happened with the secret	
70		hearing.

81	Field's actions and Ryan Berg's actions on September 13, 2012 filed
82	written complaints and written crime reports against Ryan Berg.
83	vi. Those crime reports and complaints were filed with the Fort Collins
84	Police Department and the Larimer County Sheriff's Office and the
85	situation was reported to numerous elected officials.
86	m. Ryan Berg is no longer employed with the Larimer County Sheriff's Office.

88	a. Ms. Lynne is an investigative journalist who has publicly spoken and taken
89	legal political action against Patricia Stryker, the billionaire heiress of the
90	Stryker Medical family. (EXHIBIT: Fort Collins Retort, May 4,

92	b. Julie Kunce Field worked as a litigation associate with Nutter, McClennen
93	and Fishthe same law office that was involved with a Stryker Biotech
94	company fraud lawsuit.
95	c. Julie Kunce Field completed a judicial application and listed her work
96	address as 123 North College Avenue, Suite 200, Fort Collins, Colorado.
97	d. Patricia Stryker's West Mountain Asset Management is registered with the
98	Securities and Exchange Commission as 123 North College Avenue, Suite
99	200, Fort Collins, Colorado.

115	E. "Permanent Orders Hearing"
116	The official court transcript from the "Permanent Orders Hearing" on November 15,
117	2012, shows that Julie Kunce Field violated the Colorado Rules of Evidence, the
118	Colorado Rules of Civil Procedure, the United States Constitution and the Colorado
119	Constitution. For example:
120	1. Julie Kunce Field violated Colorado Rules of Civil Procedure
121	(16.2(f)(5)/16.2(h)2 by allowing attorney Amy Antomarria to present 712
122	pages of evidence to Ms. Lynne only four days prior to the hearing.

124	2. Julie Kunce Field entirely and completely denied Ms. Lynne's evidence,

129	F. Failure by Julie Kunce Field to Serve Ms. Lynne the "Permanent
130	Order" that Field Issued "Effective Immediately"
131	a. See "Permanent Orders" that lacks the legally required "Certificate of
132	Service" that proves Julie Kunce Field intentionally did not serve Ms.
133	Lynne the order (EXHIBIT).
134	b. Julie Kunce Field's failure to serve Ms. Lynne the "Permanent Order"
135	resulted in Ms. Lynne's illegal cell phone tap, illegal arrest, and illegal

136		jailing that was performed by "officers of the court" Sergeant Jeffrey Van
137		Hook and Sergeant John Feyen.
138	c.	Most seriously, Field's premeditated actions to issue an order
139		effective immediately, and her subsequent ambush of Ms. Lynne
140		by not serving Ms. Lynne the order, forced Jaden to be used for
141		extortion and then turned over to a documented domestic
142		violence/child abuser with whom Jaden had never spent a
143		single unsupervised moment of his entire 8 years and 8 months.
144	d.	Due to Julie Kunce Field's willful and wanton illegal misbehavior, Ms.
145		Lynne was stripped of her rights to the legal and lawful contempt process,
146		including all aspects of due process of law.

153	G. Viol	ations of the Canons of the Colorado Code of Judicial Conduct
154	a.	The preamble to the Colorado Code of Judicial Conduct says that judges
155		should avoid the appearance of impropriety. In the section titled
156		"Terminology", $impropriety$ is defined as to "include conduct that violates $$
157		the law, court rules, or provision of this Code, and conduct that
158		undermines a judge's independence, integrity or impartiality."
159	b.	Rule 1.2 states: "A judge shall act at all times in a manner that promotes
160		public confidence in the independence, integrity, and impartiality of the
161		judiciary, and shall avoid impropriety and the appearance of impropriety.
162		Further, "A person's knowledge may be inferred from circumstances."
163	c.	Rule 2, section 1: "Under this Rule, a judge is disqualified whenever the
164		judge's impartiality might reasonably be questioned, regardless of whether
165		any of the specific provisions of paragraphs (A)(1) through (5) apply"

## **SUMMARY**

Julie Kunce Field is abusing her power and misusing her discretion by intentionally ignoring the honorable duties and legal and lawful requirements of her position. Julie Kunce Field is vindictively and continuously retaliating against Ms. Lynne for Field's own political and pecuniary gain. Jaden, a 9 year old innocent boy, is being used as Julie Kunce Field's weapon.
