This written statement of crimes committed by Julie Kunce Field is being voluntarily written by Stacy Lynne and has been presented to Larimer County Sheriff Justin Smith on December 18, 2012.

Enclosed with this written statement are the following documents:

- 1. Official Court Transcript from a secret hearing conducted by Julie Kunce Field on September 13, 2012:
 - a. This official transcript shows that Julie Kunce Field knowingly and illegally conducted a secret hearing in Jaden's case without Stacy Lynne's knowledge and in violation of Stacy Lynne's legal right to be notified and present.
 - b. This official transcript shows that Julie Kunce Field intentionally lied about Larimer County Sheriff's Office Corporal Ryan Berg.
- 2. Incident Report dated September 13, 2012 signed by Corporal Ryan Berg
- 3. Letter dated October 4, 2012 (regarding Ryan Berg's Incident Report) that was hand-delivered to Sheriff Justin Smith, Chief Judge Stephen J. Schapanski, Larimer County Commissioner Lew Gaiter
- 4. Copy of Stacy Lynne's Comments to the Fort Collins City Council on October 16, 2012 regarding Julie Kunce Field's secret hearing and Corporal Ryan Berg's Incident Report
- 5. Emergency Order for Void Judgment dated September 13, 2012
 - a. THIS PROPERLY PREPARED AND FILED ORDER HAS BEEN UNSIGNED FOR 96 DAYS.
- 6. Emergency Motion for Recusal and Disqualification of Julie Kunce Field dated December 13, 2012
- 7. Lexis Nexis File and Serve Transaction Report of proof that Julie Kunce Field intentionally issued an order "Effective Immediately" and at the same time did not serve Stacy Lynne the order.
 - a. This official transaction report shows that Julie Kunce Field knowingly ambushed Stacy Lynne.
 - b. This official transaction report shows that Julie Kunce Field premeditated a set-up against the Larimer County Sheriff's Office that resulted in officers acting illegally.

GENERAL CRIME REPORT

This written statement includes supporting court documents and official reports written by Julie Kunce Field and Ryan Berg. The following list is a brief summary of Field's crimes. The official documents provided with this crime report includes multiple additional pieces of evidence (that are not enumerated here) of Julie Kunce Field's crimes against Jaden and Stacy Lynne.

- 1. Julie Kunce Field violated the Colorado Rules of Civil Procedure, the Colorado Rules of Evidence, the Colorado Code of Judicial Conduct, the Colorado Constitution, and the United States Constitution on November 15, 2011 during the so-called "Permanent Orders Hearing".
 - a. Field's statutory crimes resulted in Stacy Lynne being denied the right to present legal, lawful, and properly prepared witnesses, exhibits, evidence, and testimony.
 - b. Field's statutory crimes resulted in Jaden being taken from Stacy Lynne illegally and unlawfully.
 - c. Field's statutory crimes resulted in Stacy Lynne's rights to due process being annihilated.
 - d. Field's statutory crimes resulted in Jaden being removed from his lifelong home, family, friends, pets, and school in violation of the statutory definitions of child abuse and best interests of a child.
 - e. Field's statutory crimes resulted in Jaden being court-ordered forced to live with a documented domestic violence abuser and child abuser.
- 2. Julie Kunce Field ambushed Stacy Lynne and the Larimer County Sheriff's Office on December 19, 2011 when she failed to serve Stacy Lynne an order that Field had issued "effective immediately".
- 3. Stacy Lynne was stripped of her legal and lawful right to the contempt process, all affirmative defenses, and as a result, Stacy Lynne was stripped of her natural rights and her legal responsibilities to protect Jaden from child abuse and domestic violence.
- 4. Stacy Lynne set about following the permanent order so that she could see her son as quickly as possible.
 - a. Every time that Stacy Lynne met the restrictions of the "permanent order" and therefore graduated to the next level of increased "parenting time", Julie Kunce Field further restricted (WITHOUT CAUSE, JUSTIFICATION, FINDINGS OF FACT/LAW) Stacy Lynne's access to Jaden.
 - b. This is resulting in extraordinary child abuse by Julie Kunce Field against Jaden.

- 5. Stacy Lynne has never been accused of, charged with, hinted about, or convicted of any wrongdoing in any case, and most notably, Stacy Lynne has an excellent history of being a really good mom.
- 6. Stacy Lynne has been stripped of all rights to be Jaden's mom from the sole and direct result of Julie Kunce Field's illegal and unlawful actions.
- 7. Stacy Lynne has no way to speak to Jaden or to see Jaden from the sole and direct result of Julie Kunce Field's illegal and unlawful actions.
- 8. Julie Kunce Field held a secret hearing on September 13, 2012, and then she implicated the Larimer County Sheriff's Office and the Larimer County Justice Center Security Personnel as the guilty parties for Stacy Lynne's absence from the secret hearing.
- 9. Stacy Lynne was never notified that the secret hearing was being held.
- 10. Stacy Lynne was at the Weld County Sheriff's Office, the Larimer County Sheriff's Office and inside the Larimer County Justice Center for the remainder of the day of the secret hearing and Stacy Lynne was never approached by any person regarding the secret hearing.
- 11. Julie Kunce Field held the secret hearing because during the legitimate hearing on September 13, 2012, Stacy Lynne read onto the record a partial segment of the valid void judgment.
- 12. Julie Kunce Field forced a private attorney (Traci Christy) to commit fraud through Field's deception on September 13, 2012.
- 13. Julie Kunce Field knew the void judgment was valid and that is what prompted her to exercise extreme and illegal measures to prevent Stacy Lynne from attending a hearing to defend against a matter that is potentially a contemptible and jailible offense.
- 14. Julie Kunce Field knew the "EMERGENCY ORDER TO VOID JUDGMENT" was valid. That is why she concocted the lie that Stacy Lynne left the hearing *voluntarily* and then further lied that *Stacy Lynne refused to return to the hearing*. (CORPORAL BERG ORDERED ALL COURT ROOM OCCUPANTS TO LEAVE THE BUILDING AND WE ALL LEFT WHEN WE WERE ORDERED TO GO!)
- 15. Julie Kunce Field has ordered law enforcement officers to stand down when those officers are investigating crimes that are being committed against Jaden and Stacy Lynne.
- 16. Julie Kunce Field's illegal actions over the past 13 months have resulted in Stacy Lynne being completely removed from Jaden's life without cause and without justification and at great harm to Jaden.
- 17. Stacy Lynne has never violated a court order.
- 18. Stacy Lynne has never been absent from a court proceeding. EXCEPT FOR THE ONE(S) THAT HAVE OCCURRED IN SECRET AND WITHOUT STACY LYNNE'S KNOWLEDGE!

- 19. Compare the Official Court Transcript of the Hearing from September 13, 2012 with Corporal Ryan Berg's Incident Report to see gross inaccuracies, lies and distortions that all add up to multiple statutory crimes, including child abuse, that have been committed by Julie Kunce Field.
- 20.Read the attached official court documents to read more undeniable evidence of statutory crimes that are being committed by Julie Kunce Field.
- 21. Arrest Julie Kunce Field.

SPECIFIC CRIME REPORT

- 1. Enclosed in this crime report is one audio tape that contains a conversation between Jaden and Stacy Lynne on Sunday, December 16, 2012, at 7:50 PM. During this phone conversation, Jaden tells his mom that he will never see her again. This evidence constitutes an objective credible threat against Jaden and Stacy Lynne.
 - a. A boy who is healthily attached to his good mom (the only parent he has ever known and his primary attachment figure for 8 years and 8 months) does not voluntarily tell his mom he will never see her again.
 - b. Does Jaden's comment mean that something bad is going to happen *to him* so that his mom will never see him again?
 - c. Does Jaden's comment mean that something bad is going to happen *to his mom* so that Jaden will never see her again?
 - d. How long do we wait to find out which one it is?
- 2. Jaden's case is being investigated by Deputy Justin Atwood.
- 3. Jaden's case is full of undeniable evidence of statutory child abuse, domestic violence, harassment, stalking and other crimes.
- 4. Find Jaden and return him to Stacy Lynne's protection and safety immediately.

SUMMARY

Julie Kunce Field's illegal, unlawful, blatant, vindictive violations of statutes, rules, proceedings, customs, and the law have resulted in extraordinary crimes against Stacy Lynne and Jaden. The evidence included with this crime report in no way constitutes the entirety of the official evidence on record against Julie Kunce Field. Julie Kunce Field has been breaking the law in Jaden's case since November 8, 2011. *She continues to lie and cheat and break the law simply to protect her job, and all at the expense of an innocent boy and his innocent mom.*

The purpose behind Julie Kunce Field's willful, knowing and wanton statutory crimes is to protect herself, to shield her fellow attorneys and judges, and to hide the corrupt legal system so that it cannot be exposed by Stacy Lynne.

Julie Kunce Field premeditated the illegal and unlawful taking of Jaden from his mom, Stacy Lynne nearly one year ago. Field's illegal actions began on November 8, 2011, and are continuing today have caused Jaden to suffer unimaginable trauma and abuse. Field's actions have directly placed the Larimer County Sheriff's Office in the path of multiple ambushes, set-ups, and illegal and unlawful actions.

Julie Kunce Field is actively and knowingly promoting child abuse and domestic violence in Jaden's case through her willful and wanton illegal actions.

THE EVIDENCE IS CONTAINED HEREIN. THE EVIDENCE IS UNDENIABLE. PLEASE HELP MY SON AND ME.

I, Stacy Lynne, am a woman possessing all natural and constitutional rights, and being of sound mind and body, do swear under penalty of perjury that I have voluntarily written this report of crimes committed by Julie Kunce Field. The statements set forth herein are true and correct.

This crime report has been filed with Larimer Sheriff Justin Smith, other officials, and with the people.
