TO: Colorado State University Police Department

Attached to this letter are five photographs that were taken on May 2, 2012 at approximately 12:30 PM. These photos are evidence of an incident that I would like included in a complaint against Sergeant Chris Robertson.

At approximately 10:30 AM on Wednesday, May 2, 2012, I was walking laps around the running track at the old Fort Collins High School. There is a dog park on the south side of the track and on the west side of the track is the Colorado State University Center for the Arts. There was no one else on the track or at the dog park except for me when what appeared to be a City of Fort Collins police officer drove his motorcycle onto the running track. He entered the track just behind me, drove his motorcycle extremely slowly for one complete lap on the track and then exited just behind where I was walking. As he drove around the track, he maintained his head position in my direction at all times.

As soon as the officer entered the track, I called a friend, so that I could make a record of the situation as it was happening. I did not have my camera with me at the time, however, I returned to the track two hours later to photograph the tracks.

I also called a few other friends just after the incident to explain how strange it was for the officer to slowly drive his motorcycle around the track all the while never turning his head away from me, even when he was driving around the entire lap.

On May 3, 2012, I went to the Fort Collins Police Department downtown station and main station to inquire whether this was truly a FCPD officer or possibly an impersonator. Besides wondering if this was a man impersonating an officer, I wondered if there may have been crime in the area and the officer was simply making sure I was safe. Obviously though, it is highly unusual for a uniformed officer to drive his motorcycle onto a running track. This could have been an innocent event, but it just didn't seem normal.

I do not have a description of the motorcycle rider because he had his helmet on and was fully covered with boots, gloves, etc. The bag on the rear of the motorcycle was marked "POLICE".

I spoke with desk officers at the downtown Fort Collins Police Department and at the main station. Those officers, being concerned about the possibility of a police impersonator, helped me discover that the motorcycle rider was a Colorado State University police officer named Sergeant Chris Robertson.
