Now comes Stacy Lynne, mother of Jaden, being of sound mind and body and possessing total natural and Constitutional rights, to file this NOTICE OF ADMINISTRATIVE MEETING RE: DRIVER'S LICENSE SUSPENSION.

BACKGROUND

1. On September 13, 2012, Julie Kunce Field, acting as judge in the Eighth Judicial District, in the city of Fort Collins, county of Larimer, state of Colorado held an illegal and unethical secret hearing related to "child support". **The illegal and unethical nature of that secret hearing has gone undisputed by Julie Kunce Field for 11 months because Julie Kunce Field has no defense to the facts that are on record with the Larimer County Sheriff's Office and in the official court transcript that is in the possession of Judicial Administration (Janelle Brunin) and in case file 2011 DR 444.** The illegal and unethical violations are outlined in: Colorado Bar Association Rules of Conduct, the Colorado Judicial Canons, Colorado Revised Statutes, Colorado Court Rules, Colorado Rules for Civil Procedure, Colorado Rules for Evidence, the Colorado Constitution and the United States Constitution.

- 19 **2.** On an unknown date, an “order” was mailed by an unknown entity to Stacy
20 Lynne. **The “order” was not dated. The “order” was not signed.** The
21 “order” listed courtroom 5D (a judge’s courtroom), and the BLANK signature line
22 said “magistrate”. (EXHIBIT 1)
- 23 **3.** On May 24, 2013, an “order” was mailed by “Carolyn B. Pannell, Magistrate” to
24 Stacy Lynne. The “order” says that “The motion/proposed order attached hereto:
25 GRANTED”. **There was nothing attached to the “order”. There was**
26 **nothing else in the envelope.** Carolyn B. Pannell had been previously legally
27 served notice of claim against her. Pannell’s issuance of an “order”, even though
28 she failed to attach an “order”, is a direct conflict of interest. (EXHIBIT 2)
- 29 **4.** On June 20, 2013, a “DRIVER’S LICENSE SUSPENSION NOTICE OF
30 NONCOMPLIANCE WITH A CHILD SUPPORT ORDER” was mailed to Stacy
31 Lynne. (EXHIBIT 3)
- 32 **5.** On July 18, 2013, Stacy Lynne filed a written NOTICE OF ADMINISTRATIVE
33 REVIEW RE: DRIVER’S LICENSE SUSPENSION with Sarah Esquibel, Sean
34 McGill, Family Support Registry, State Department of Human Services and the
35 Larimer County Clerk of Courts. That written notice was nearly 300 pages and
36 included verifiable evidence that the original “child support order” was issued
37 using illegal and fraudulent tactics.
- 38 **6.** On July 19, 2013, Sarah Esquibel mailed a letter dated July 18, 2013, to Stacy
39 Lynne. (EXHIBIT 4) The letter from Sarah Esquibel said the Administrative
40 Review of arrearages is scheduled on August 13, 2013, at 9:00 AM at 2601
41 Midpoint Drive. Sarah Esquibel continues in the letter: “You do not need to
42 come to this office for the review to take place. Please mail to this office by
43 07/18/2013:”
- 44 **a. It is impossible for Stacy Lynne to respond in writing to Sarah**
45 **Esquibel “by 07/18/2013” to a letter that was not mailed until**
46 **July 19, 2013.**
- 47 **7.** On August 12, 2013, Stacy Lynne hand-delivered a letter dated August 12, 2013,
48 to Sarah Esquibel and Sean McGill informing them that Stacy Lynne would
49 personally attend the Administrative Review as scheduled. (EXHIBIT 5)

50 **SUMMARY**

51 The seven above-enumerated points show a pattern of blatant fraud and abuse of
52 power by Sarah Esquibel and Sean McGill. The evidence of their fraud, abuse, and gross
53 negligence is shown in the attached EXHIBITS and does suggest criminal intent by
54 Sarah Esquibel and Sean McGill.
